Blow off hardscapes, walkways, and parking areas.

Police debris and trash about turf areas.

Maintain shrubs/planter beds along Cheney hwy.

Apply weed killer where necessary.

Schedule:

Weekly service April through mid-October.

Bi-weekly service November through ~~April~~ March

1 monthly service during the month of December.

This results in 36 service visits annually, depending on weather conditions.

The cost of this service will be \$2800.00 monthly. This would be an annual agreement with the ability to terminate said agreement for any reason with 45 days' notice.
