Wood destroying Organisms (including carpenter ants) are excluded from this category.

Flea Control: Service to be rendered for the control of fleas and ticks. An additional \$ 10 per treatment will be charged.

Exterior Service [Lawn, Shrub & Tree]

(I) Insect Control: Service to be rendered for the control of chinch bugs, mole crickets, army worms, sod web worms, grubs, ants, fleas, and ticks in lawns, scale, mealy bugs, thrips, aphids, whiteflies, caterpillars, worms, and mites in shrubs and trees.

(D) Disease Control: Service to be rendered for the control of various fungi, bacteria and viruses including brown patch, dollar spot, fairy ring, and grey leaf spot.

(F) Fertilization: Service will include the application of "complete" granular fertilizers such as 16-4-8, 8-10-10, 22-5-11, depending upon the soil analysis. These applications may be supplemented with additional liquid fertilizer products when necessary.

(W) Weed Control: Service to be rendered for the control of both broad leaf and grassy weeds.
