

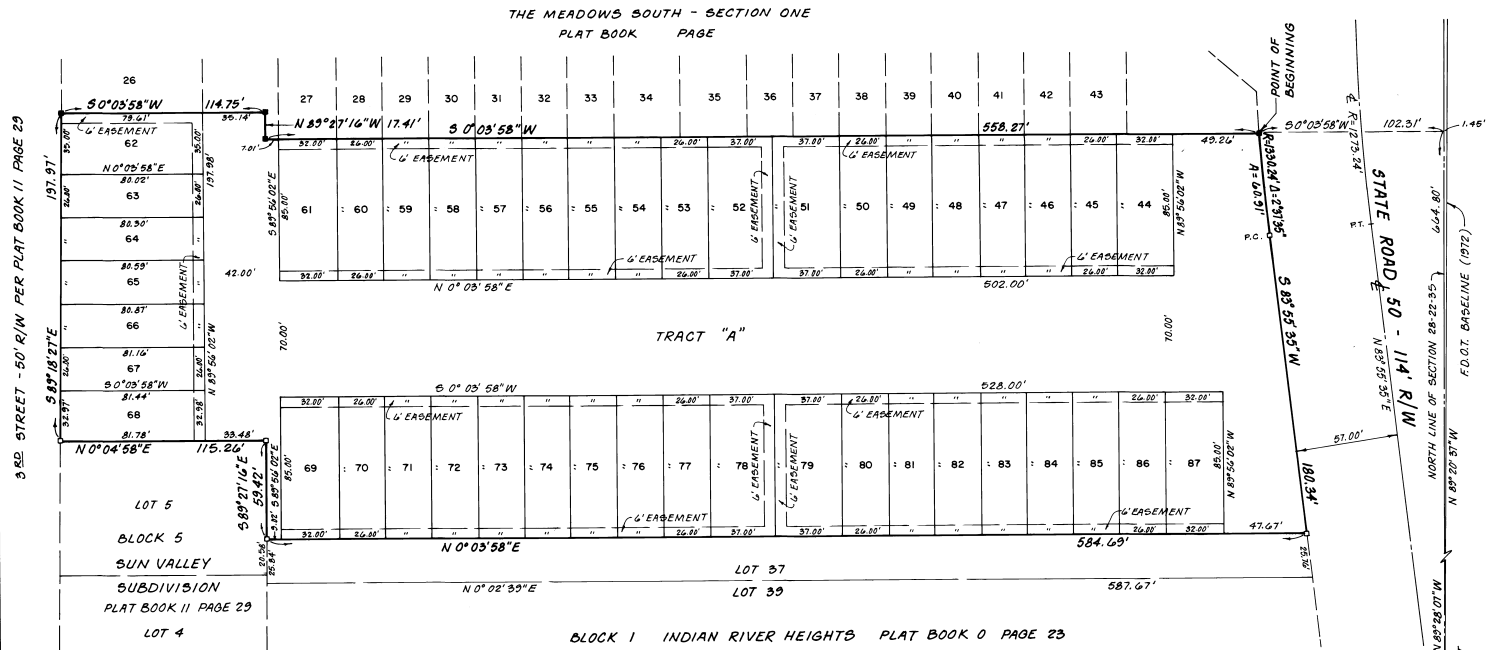
# THE MEADOWS SOUTH - SECTION TWO

A REPLAT OF ALL OF LOT 36 AND PART OF LOTS 35 AND 37 BLOCK 1, INDIAN RIVER HEIGHTS, AS RECORDED IN PLAT BOOK 0 PAGE 23; TOGETHER WITH A PART OF LOT 8, AND ALL OF LOTS 6 AND 7, BLOCK 5, SUN VALLEY AS RECORDED IN PLAT BOOK 11 AT PAGE 29; ALL ACCORDING TO THE PUBLIC RECORDS OF BREVARD COUNTY, FLORIDA.

## LEGAL DESCRIPTION:

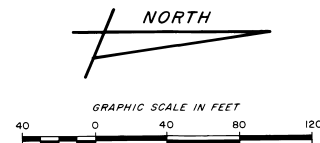
COMMENCE AT THE NORTHEAST CORNER OF SECTION 28, TOWNSHIP 22 SOUTH, RANGE 35 EAST, BREVARD COUNTY, FLORIDA; RUN THENCE N 89° 28' 07" W ALONG THE NORTH LINE OF SAID SECTION 28, A DISTANCE OF 444.80 FEET; THENCE S 0° 05' 58" W, 102.31 FEET TO THE NORTHEAST CORNER OF THE MEADOWS SOUTH - SECTION ONE AS RECORDED IN PLAT BOOK 31 PAGE 11 OF THE PUBLIC RECORDS OF BREVARD COUNTY, FLORIDA; THENCE ALONG THE BOUNDARY OF SAID THE MEADOWS SOUTH - SECTION ONE THE FOLLOWING THREE COURSES AND DISTANCES: S 0° 03' 58" W, 558.27 FEET; N 89° 27' 14" W, 17.41 FEET; S 0° 05' 58" W, 114.75 FEET TO A POINT ON THE NORTH RIGHT-OF-WAY LINE OF S 52 STREET (A 50' R/W); THENCE S 89° 18' 27" E ALONG SAID NORTH RIGHT-OF-WAY LINE, 197.97 TO THE SOUTHWEST CORNER OF LOT 5, BLOCK 5, SUN VALLEY SUBDIVISION AS RECORDED IN PLAT BOOK 11 AT PAGE 29 OF THE AFORESAID PUBLIC RECORDS; THENCE ALONG THE BOUNDARY OF SAID LOT 5 BLOCK 5 THE FOLLOWING TWO COURSES AND DISTANCES: N 0° 04' 58" E, 116.24 FEET; S 89° 27' 16" E, 59.42 FEET; THENCE RUN N 0° 05' 58" E, 584.65 FEET TO A POINT ON THE SOUTH RIGHT-OF-WAY LINE OF STATE ROAD 50 (A 114' R/W); THENCE ALONG SAID SOUTH RIGHT-OF-WAY LINE THE FOLLOWING TWO COURSES AND DISTANCES: S 89° 55' 35" W, 180.34 FEET TO THE POINT OF CURVATURE OF A CIRCULAR CURVE CONCAVE NORTHERLY HAVING A RADIUS OF 1930.24 FEET; WESTERLY ALONG THE ARC OF SAID CURVE THRU A CENTRAL ANGLE OF 2° 31' 35", A DISTANCE OF 60.91 FEET TO THE POINT OF BEGINNING. CONTAINING 44 LOTS AND 3.668 ACRES MORE OR LESS.
